#### **Financial Aid Information**

The Transition and Access Program, (TAP) is a <u>Comprehensive Transition Postsecondary Program</u> (CTP), which means eligible students may receive funding from the Federal Pell Grant, Ohio College Opportunity Grant, Federal Supplemental Educational Opportunity Grant, and Federal Work-Study programs.

In order to qualify, students will have to complete a FAFSA (Free Application for Federal Student Aid. Since some aid programs are awarded on a first-come, first-serve basis, apply as soon after October 1 of each year for priority consideration for limited funding sources.

- Go to www.fafsa.ed.gov
- Will need to have a FSA-ID (fsaid.ed.gov)
- The 2021-22 FASFA form will ask fo 2019 taxes
- Apply early
- The federal processor analyzes your FAFSA information to determine an Expected Family Contribution (EFC).
- This will then go to the financial aid office to see if the student meets EFC (Expected Family Contribution) criteria that will qualify them for grants or work study programs.
- You may be asked to supply additional information.
- UC will detail if additional or supplementary information is needed and send you email notifications as well.
- An estimation of aid eligibility will be displayed that cannot be acted on until the requested information is provided to UC and processed by us.
- Please act on requests for information as quickly as possible.

- Federal Pell Grant-
  - Does not have to be repaid
  - o \$0-\$6345 annually
- Ohio College Opportunity Grant
  - o Does not have to be repaid
  - o \$0-\$2000 annually
- Federal Supplemental Educational Opportunity Grant-
  - Does not have to be repaid
  - o \$0-\$1200 annually
- Federal Work Study Program-
  - Work-Study lets you work and earn money to help pay for your costs. It is a need-based employment opportunity given to you as part of your financial aid package.
  - \$0-\$3000 annually

**Advisory**: These are not definite amounts. Eligibility criteria subject to change; maximum amounts are estimates and dependent upon sufficient funding.

Early FAFSA application means limited funding; awards are made on a first-come, first-serve basis until funding is depleted.
